Discussion:

Chief Grice stated the old squad car was sold for \$6,800. When we receive this check it will be put into the patrol car fund.

Continued Business:

Clean up Days for September 2021 are on hold – Supervisor Saunders explained he has been trying to get in touch with Mr. Roberts and if he won't then try to find someone else to work it. Treasurer Kuriata stated she saw Mr. Roberts and he said he'd be happy to do it, but he hasn't contacted Supervisor Saunders yet.

Opening Township Building – discussion – July 1st is target date to unlock the front door. We have always served residents who come to the township but we won't have the locked door, etc.

Public Comment

David Benton from Indian Lake commented during the lake board discussion that he was on Indian Lake committee when the SAD originally started and he has been very displeased with things have progressed. He reported management problems between different entities and it was hard for them to

identify who was in charge (MDEQ, drain commissioner). He would like to see the focus include all the inlets, not just one inlet. Right now, lakes are suffering from a drought and they have an outlet, but they don't have an official lake level, so can't have a dam to make adjustments. He stated for him, having a lake board makes total sense. He said it's time to stop throwing money at the problem and they need to work with the other organizations. He is passionate about Indian Lake and it's been his life's dream to live there.

Tom Wilson of Sister Lakes Cable explained the plan to bring fiber optic broadband to the Haley Subdivision as their first test case since they have extra fiber in the area already.

County Commissioner Mike Grice stated the County Planning Commission has a broadband committee and referred Tom Wilson to coordinate with that committee. It was noted our township may be eligible for federal funding for expanding broadband, so we should coordinate with Tom and the county.

Chief Mike Grice stated the Sheriff's Department changed their report writing system in May and after some research he wants to use Core Technology for the Township police department.

During the lake board discussion, Commissioner Grice noted he has been on a lake board for 5 years in his role as county commissioner for Stone Lake in Cassopolis. He stated it works very well and the drain commission is on it and also attends. He was impressed with how the community endorsed the lake board. The lake board has made a huge improvement in that lake, for fishing and other recreation. He stated they now have some expertise if we want to talk to them in making it work successfully.
