Attorney's Report: John Magyar had nothing to report

Ad-hoc Committee Report: The committee communicated by email and Walt Lehman drafted a letter asking for proposals from a list of businesses that was compiled by committee members. The committee received several proposals Walt Lehman will make copies of each proposal and it will be available for the Planning Commission, so that can review the proposals that were received. Terry Harris mentioned that all the proposals were close in dollars. The commission would like time to look over the proposals.

One of the proposals was submitted by Marc Edelsen and he asked that his proposal cost not be submitted to the public until a decision is made about who will get the job. Terry Harris suggested that in the future the commission should ask for sealed bids.

Dave Grabmeyer asked if the ad-hoc committee was going to narrow down the choices or was the commission going to review all of the proposals and discuss them together? The commission will review each one and discuss them together.

Tom Lehrer asked John Magyar, "How do you compare the proposals?" John suggested checking on the companies past work, get references and whether they would be recommended by past customers.

Bill Saunders asked if the Silver Creek Board allocated enough money to cover the cost of a consultant. Walt Lehman and Tom Lehrer both stated that it was close.

Tom Lehrer made a motion to have the Ad-hoc committee meet again review the proposals and bring back three proposals they would like the commission to review at the next meeting. Walt Lehman supposed the motion.

New Business

Bill Zuhl asked Bill Saunders if the Commission could get a list of the Capital Improvements for Silver Creek. Terry Harris asked if Silver Creek painted their own safety lighting. He was told no that this would be have to be a special assessment.

Proposed changes to Chapter 6.02 (Maintenance equipment) will be table until the next meeting.

Commission Comments: Mike Glynn stated how impressed he was with the Ad-hoc committee and the work that they had done so far on finding a consultant.
